Important Notices:

The **safety and well-being of our Active DeMolay participants** is paramount to us. DeMolay International and Pennsylvania DeMolay hold to ***strict regulations*** regarding the adult volunteers who we place in charge of our youth. Although the Advisor Track is open to individuals who are not currently registered DeMolay Advisors, they will **NOT** be in supervisory roles with Active DeMolay Conference participants at any time. All participants in the Advisor Track must be ***21 years of age or older***. The Conference Directors reserve the right to refuse any application with or without cause.

As an adult participant, you will **not** be required to file a ***medical history and release form***. We do, however, ask that you make Conference staff aware of any special medical needs you have that may affect your participation in the activities of the Conference. Conference participants tend to keep long hours and a busy daily schedule, often including outdoor and sporting activities, during their stay with us.

Be aware that Pennsylvania DeMolay holds to a ***strict policy*** regarding the ***use of tobacco*** by any person at a DeMolay event. The Masonic Conference Center in Elizabethtown is a non-smoking facility. There is no smoking permitted anywhere on campus at any time. Providing tobacco to any person under 18 is illegal in Pennsylvania. Possession or use of any form of ***alcohol or illicit drugs***, whether by an adult or a minor, is not permitted at any time during the Conference. If you feel you cannot comply with these requirements, please do not apply.
